

DNA Software, Inc. Online Terms and Conditions

- 1. Binding Contract; Sole Terms.** These Online Terms and Conditions, together with: DNA Software's website order form to which these terms are linked (**DNA Software's Quotation**); any applicable label, license or written Product warranty; and any other terms and conditions expressly agreed to in writing by an authorized representative of DNA Software or linked from the online Product sale page to which these Online Terms and Conditions are linked (collectively, **Terms**), govern the purchase and sale of DNA Software's products listed on the website checkout page to which these Terms are linked (**Product(s)**) and constitute the entire agreement and understanding of between the entity or individual purchasing the Products (**Buyer**) and DNA Software (**DNA Software**). DNA Software's offer to sell is expressly limited to the Terms. Buyer's issuance of a purchase order to DNA Software or acceptance of delivery for any Products provided hereunder shall be for administrative purposes only and shall constitute Buyer's acceptance of the Terms without modification or supplementation. The Terms shall take precedence over and supersede and replace all prior or contemporaneous understandings or agreements, written or oral, and any of Buyer's additional or different terms and conditions, which are hereby rejected in their entirety and shall be void.
- 2. Price; Taxes and Other Charges.** Prices for the Products stated on the online checkout form are exclusive of all taxes, fees, licenses, duties or levies and, unless otherwise expressly stated in DNA Software's Quotation, transportation charges, freight and insurance. Any use tax, sales tax, excise tax, duty, inspection or testing fee, or any other tax, fee or charge imposed by any governmental authority on or measured by the purchase of any Products, as well as any fee, license, duty, levy or transportation, freight or insurance charge applicable to such Products, is the responsibility of the Buyer.
- 3. Payment Terms.** Payment Terms for all Products are to be made at the time of Product purchase. Payment to DNA Software for Products purchased must be made by credit card or bank transfer to the address or bank account (as appropriate) on the invoice. Payment must be in US dollars.
- 4. Delivery, Title, and Risk of Loss.** DNA Software will use reasonable efforts to ship Products within a reasonable time after ordered as set forth in the Terms, or, if a shipment date is indicated in DNA Software's Quotation, on or before such date. DNA Software may make delivery in installments, and each installment shall be deemed to be a separate sale for which DNA Software may invoice, and Buyer shall pay separately. Any quoted delivery date is only an estimate and not a guarantee. Unless indicated otherwise in DNA Software's Quotation, title and risk of loss or damage with respect to all Products shall pass from DNA Software to Buyer when Products are delivered by DNA Software to the carrier for shipment to Buyer. Any and all claims by Buyer for damage, loss or delays in transit shall be made by Buyer against the carrier (with notice thereof to DNA Software), and DNA Software shall have no responsibility, liability or obligations with respect to any such damage, loss or delay. Buyer shall have the right to pre-approve the selected shipping company and shall also pre-approve the quality of any packaging and method of shipping.
- 5. Rejection.** Any claims for damaged, missing or defective Product must be reported in writing by Buyer within 5 days from the date of its receipt of Product as set forth in the applicable shipping manifest. In addition, Buyer must promptly return a rejected Product to DNA Software, C.O.D, accompanied by a valid return authorization number obtained from DNA Software. DNA Software may refuse any Product not timely rejected or sought to be returned without a valid return authorization number. For any valid claim timely made, DNA Software, at its sole discretion, may either repair Product or replace Product with an identical or substantially similar product or refund the purchase price actually paid for the Products. **THESE ARE BUYER'S SOLE AND EXCLUSIVE REMEDIES AND DNA SOFTWARE'S SOLE LIABILITIES FOR DAMAGED OR MISSING PRODUCTS, AND, EXCEPT FOR EXPRESS WARRANTY RIGHTS, FOR DEFECTIVE PRODUCTS.**
- 6. Warranty; Disclaimer.** DNA Software makes only those warranties with respect to any Product expressly identified as "warranties" and set forth in the specific written warranty included with and covering that Product, if any, in addition to any warranty description contained in DNA Software's Quotation, each as may be set forth in the Terms. **ANY PRODUCT NOT COVERED BY A WRITTEN WARRANTY IS SOLD "AS IS." DNA SOFTWARE EXPRESSLY DISCLAIMS ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR ANY PARTICULAR PURPOSE AND, SUBJECT TO THE PROVISIONS OF SECTION 11 BELOW, NON-INFRINGEMENT.** DNA Software disclaims any and all responsibility for any rights or licenses to patents or other intellectual property that may be required from third parties, and/or liability with respect to such third party patents or other intellectual property.
- 7. Prohibited Activities. The Product is to be used for research use ONLY.** Buyer shall not: (i) resell, distribute, supply, license or otherwise commercialize any of the Products; (ii) use of any of the Products to carry on or conduct any service business, including, without limitation, any COVID testing; (iii) alter, modify or reverse engineer any of the Products; (iv) decompile, disassemble or otherwise attempt to derive any source code of any software included in any of the Products; (v) use for the purpose of discovering, creating or inventing improvements or modifications to any of the Products or for the purpose of developing for commercial purposes any new imaging equipment or new reagents, kits or consumables; or (vi) use the Products other than by Buyer as

an end user thereof to conduct development activities at Buyer's premises for the benefit of Buyer. Notwithstanding these prohibitions, to the extent that any know-how, trade secrets, copyrightable materials, information, design, documentation, drawings, source code or invention(s) directly relating to any improvements to any Product is created, conceived, reduced to practice or otherwise developed by Buyer as a result of Buyer's use of any Product(s), Buyer agrees to grant and hereby grants DNA Software a perpetual, non-exclusive, royalty-free commercial license in said inventions as necessary for DNA Software to fully and freely exercise its rights in the Products. The provisions of this Section 7 shall be binding and enforceable against Buyer's direct and indirect parent companies, subsidiaries, affiliates, sublicensees, and permitted successors and assigns, and shall inure to the benefit of any successor or assignee of DNA Software, regardless of whether such succession or assignment is voluntary or by operation of law.

8. **Force Majeure.** DNA Software shall not be liable for any delay or failure of performance, including without limitation failure to deliver or failure to install, where such delay or failure arises or results from any cause beyond DNA Software's control, including, but not limited to, flood, unusually severe weather, earthquake or other act of God, power loss, strike, boycott, or other labor disputes, embargo, governmental regulation, government restriction or an inability or delay in obtaining materials. In the event of any such delay or failure of performance, DNA Software shall have such additional time within which to perform its obligations hereunder as may be reasonably necessary under the circumstances; and DNA Software shall also have the right, to the extent necessary in DNA Software's reasonable judgment, to apportion Products then available for delivery fairly among its various customers in such manner as DNA Software may consider equitable.
9. **Infringement of Intellectual Property.** If the intended use as set forth in the Terms of any Product sold by DNA Software to Buyer becomes the subject of a third party suit alleging that such use infringes a valid U.S. patent of such third party or constitutes a misappropriation of a trade secret of such third party ("**Infringement Claim**"), Buyer shall promptly notify DNA Software in writing of such Infringement Claim, and upon receipt of which, DNA Software shall defend and indemnify Buyer in connection with such Infringement Claim. In addition to the foregoing and at its sole discretion, DNA Software shall have the right to: (i) procure for Buyer the right to continue practicing the intended use of the DNA Software Product; or (ii) replace or modify any DNA Software Product so that the intended use becomes non-infringing; or (iii) require Buyer to return any DNA Software Product that is the subject of the Infringement Claim and upon return, refund to Buyer the price actually paid by Buyer for the returned Product, pro rata based on the period of time from receipt of the DNA Software Product by Buyer to return using three-year straight-line depreciation. Further, if, in DNA Software's opinion, the intended use of the DNA Software Product is likely to become the subject of an Infringement Claim (or other claim by a third party for infringement of intellectual property rights), DNA Software may also, at its sole discretion but without obligation, in accordance with subsections (i), (ii) or (iii) so procure continuing rights, replace or modify, or pro rata refund the price actually paid. In addition to, and not in limitation of, the provisions of Section 7, above, DNA Software shall have no liability or obligation under this Section 9 for any Infringement Claim based upon, arising from or caused by: (a) the use of any DNA Software Product in combination with any system, reagent, or material not provided by DNA Software or not intended for use with DNA Software Products, or based upon any modification to any DNA Software Product made by Buyer or a third party; (b) any modification to any DNA Software Product, whether made by DNA Software, Buyer, or any third party, and made at the request or direction of Buyer; or (c) any use of any DNA Software Product other than for the express use for which such DNA Software Product is sold by DNA Software as set forth in the Terms; or (d) Buyer's continued use of any DNA Software Product subsequent to Buyer's receipt of notice of an Infringement Claim. THE FOREGOING STATES THE ENTIRE LIABILITY OF DNA SOFTWARE, AND THE EXCLUSIVE REMEDY OF BUYER, FOR ANY INFRINGEMENT, INFRINGEMENT CLAIM OR CLAIMED INFRINGEMENT OF ANY PATENT OR OTHER INTELLECTUAL PROPERTY RIGHT, OR MISAPPROPRIATION OR CLAIMED MISAPPROPRIATION OF ANY TRADE SECRET, BY ANY AND ALL DNA SOFTWARE PRODUCTS OR ANY PART THEREOF OR USE THEREOF.
10. **Limitation of Liability.** TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL DNA SOFTWARE BE LIABLE TO BUYER, WHETHER IN CONTRACT, TORT (INCLUDING WITHOUT LIMITATION, NEGLIGENCE), WARRANTY, OR UNDER ANY STATUTE OR ON ANY OTHER BASIS FOR: SPECIAL, INCIDENTAL, INDIRECT, PUNITIVE, MULTIPLE OR CONSEQUENTIAL DAMAGES SUSTAINED BY BUYER OR ANY OTHER PERSON OR ENTITY ARISING OUT OF, RESULTING FROM OR RELATING TO THE MANUFACTURE OR SALE OF PRODUCTS, DNA SOFTWARE'S PERFORMANCE OR FAILURE TO PERFORM ITS OBLIGATIONS, THE POSSESSION OR USE OF ANY PRODUCT, OR THE PERFORMANCE BY DNA SOFTWARE OF ANY SERVICES, WHETHER OR NOT FORESEEABLE AND WHETHER OR NOT DNA SOFTWARE IS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, INCLUDING WITHOUT LIMITATION DAMAGES ARISING OUT OF, RESULTING FROM OR RELATED TO LOSS OF USE, LOSS OF DATA, DOWNTIME, LOSS OF REVENUE, PROFITS, GOODWILL, OR BUSINESS OR OTHER FINANCIAL LOSS, AND DNA SOFTWARE'S AGGREGATE DAMAGES FOR ANY AND ALL CLAIMS ARISING OUT OF, RESULTING FROM OR RELATING TO THE MANUFACTURE OR SALE OF PRODUCTS, DNA SOFTWARE'S PERFORMANCE OR FAILURE TO PERFORM ITS OBLIGATIONS, THE POSSESSION OR USE OF ANY PRODUCT, OR THE PERFORMANCE

BY DNA SOFTWARE OF ANY SERVICES, SHALL BE LIMITED TO THE PRICE ACTUALLY RECEIVED BY DNA SOFTWARE FROM BUYER FOR THE AFFECTED PRODUCT.

11. **Compliance with Laws.** Buyer agrees to comply with all applicable laws, including export laws and restrictions and regulations of any applicable government or authority.
12. **No Grant of Rights.** Nothing in this Agreement shall be interpreted expressly or impliedly as: (i) granting to Buyer any license or other rights except as expressly set out in the Terms; (ii) granting Buyer any right in or to the intellectual property of DNA Software or the Products; or (iii) granting Buyer the right to resell or convey in any manner the Products to any third party anywhere in the world.
13. **Choice of Law.** Any contract between DNA Software and Buyer relating to Product(s), including the Terms, and any disputes relating thereto, shall be governed by, and construed in accordance with the laws of the state of Michigan. Buyer hereby irrevocably and unconditionally submits to the sole and exclusive jurisdiction of the courts in Ann Arbor, MI, USA provided however, that DNA Software may commence action for injunctive relief (including interlocutory or mandatory relief) at any competent court.
14. **Confidentiality.** Buyer acknowledges that it may have access to certain information and materials concerning the Products and other proprietary information that is confidential and of substantial value to DNA Software, which value would be impaired if such information were disclosed to third parties or used by Buyer for anything other than for the purpose of, and as permitted in, the Terms (**Confidential Information**). Buyer agrees to receive in confidence any such Confidential Information and not to disclose any of the Confidential Information to any other person or corporation, and to use the Confidential Information only for its own use in accordance with the Terms. Buyer undertakes to bind its employees and officers to the terms and conditions contained herein in writing. Buyer shall return all Confidential Information, including all copies thereof, to DNA Software upon DNA Software's request.
18. **Miscellaneous.** The waiver of performance of any of the terms or conditions herein shall not be construed as a waiver of subsequent obligations to perform the same or additional terms and conditions. Should any provision of the Terms be held invalid or void for any reason, the remaining provisions shall remain in full force and effect. The headings are for convenience only and shall not be used in construing the Terms.
